SECTION 3: COMMUNITY GROUP ACCEPTANCE TERMS

1. All electrical leads must be tested & tagged by an authorised person, maintained in good condition and must not obstruct persons walking in the vicinity. Testing & Tagging can be provided on site for \$3 per appliance.
2. Our Market operates on Larrakia land and **under no circumstances** may any person peg anything into the ground. Substantial fines are payable to the traditional land owners if caught pegging on site. To secure stall structures, performers should consider using ropes, sandbags or weights.
3. All vehicles must be out of Market area by 3:30pm on Thursdays & Sundays.
 - Vehicle's speed is limited to 5km/hour in the market area at any time of the day or night. Due care must be taken in all areas of the market including the public and stallholder car park.
 - Hazards lights must be activated once the vehicle enters the market area and are to remain on until well outside the market area.
4. No smoking in the Market area. You may utilise the designated smoking areas or public car park area for smoking.
5. All community groups / organisations must check in with the information booth on arrival or contact the Entertainment Coordinator.
