MBSMA - Handmade Policy

Mindil Beach Sunset Market actively supports and encourages Northern Territory and Australian business. Our overall Market ethos is to focus, promote and showcase locally designed and handmade products.

To support the integrity of designers and their original concepts and products, Mindil Beach Sunset Market have implemented a Handmade Policy which applies to all Stallholders and the products they sell.

Stallholders must identify where they fit within the Design and Manufacture Categories (below) with Stallholders required to supply supporting evidence as requested. This information forms an integral part of the Stallholder's Application and must be completed and submitted at time of Application lodgement.

Design and manufacture categories

Self-designed / Handmade:

Designs and Manufacture of products are done solely by the Applicant

- Products must be Self-designed and Manufactured solely by the Applicant.
- Must be able to demonstrate where design concepts and ideas come from.
- Must be able to explain the processes of how each product is manufactured.
- Must be able to explain what workspace / tools and equipment are used.
- Must be able to state where all raw materials used are sourced from.
- Must be able to provide examples (i.e. photography) of the design and manufacture process.
- Must state whether produced are Mass Produced / Limited Runs / Originals "One-Offs"

Self-design with External/Contracted Manufacturer:

Designs are created by the Applicant with External/Contracted Manufacturer

- Products must be Self-designed by the Applicant but Manufactured by an external Manufacturer.
- Must be able to demonstrate where design concepts and ideas come from.
- Must state whether products are Mass Produced / Limited Production / Originals "One-Offs"

Commercial:

Design and Manufacture is completed through an external/contracted supplier/source
